<u>Active Duty Sponsored-</u> Must provide a copy of Orders & Area clearance with family members listed.

<u>Civilian Employee Sponsored-</u> Must provide Letter of Employment with family members listed. For CONUS hired, please include Travel orders & Area Clearance with family members listed.

<u>Contractor Sponsored-</u>Must provide Letter of Authorization/Contract & a SOFA Status Verification Letter.

Parent/Guardian Agreement-Teens under 18, signed by parent.


Must complete NOWA, fill out the Registration form and fulfill the requirements below.
