_____ RENTOR hereby acknowledges that he/she has read and understands Base Order 5101.1A of 19 DEC 2016 (SOP for Recreational Water Activities).

_____ RENTOR has read and understands the current sea conditions in both the East and West sectors of Okinawa. RENTOR also understands that it is his/her responsibility to be aware of the current sea conditions and to accurately assess his/her abilities according to his/her experience/certification level. The final decision, regardless of posted sea condition, of whether or not to enter the water rests with the RENTOR.

_____ RENTOR hereby acknowledges receipt of the equipment designated on this form and has knowledge/experience regarding its intended use. If any of this equipment is used for scuba diving, that RENTOR is a certified scuba diver.

_____ RENTOR having acknowledged Base Order 5101.1A above further acknowledges his/her understanding of the required equipment for Scuba Diving and Snorkeling and how to operate the equipment being rented.

_____ **Snorkelers Only** – I hereby decline the required snorkeling vest offered by MCCA Tsunami Scuba at no charge.

_____ RENTOR acknowledges that the equipment is in good working condition and that he/she has examined the equipment to ensure that it is free from obvious defects, including checking quantity of air in any scuba tank(s) rented.

_____ RENTOR also understands that Tsunami Scuba and its employees, owners, officers, or agents (hereinafter "Released Parties"), shall not be held liable or responsible in any way for any injury, death or other damages to RENTOR or his family, heirs, or assigns which may occur as a result of the rental and/or use of the equipment, or as a result of product defect, or the negligence of any party, including the Released Parties, whether passive or active.

_____ RENTOR agrees to reimburse Tsunami Scuba for the loss or breakage of any and all equipment at the current replacement value and to also pay for damages incurred while transporting the equipment.

_____ RENTOR understands that there will be no refunds/rental credits for rental equipment except for a cancellation of class, declaration of Sea Condition Danger, or operational commitment i.e. recalled to duty (must have documentation). Equipment must be returned UNUSED within two hours of change in Sea Condition; if the facility is closed, the equipment must be returned within the first hour of operation the next business day.

_____ RENTOR agrees to pay a \$50.00 inspection service charge if the regulator is returned without the dust cover replaced correctly.

_____ RENTOR understands that all equipment is due no later than 30 minutes prior to closing the following day of rental and that, the RENTOR will be charged an additional day's rental fee for equipment returned after that time.

_____ **YOU, THE RENTOR, MUST PERSONALLY RETURN THE EQUIPMENT. NO ONE ELSE CAN RETURN THE GEAR FOR YOU. NO EXCEPTIONS!!!!**

_____ **YOU, THE RENTOR are responsible for the return of the equipment issued to you as notated on this rental agreement. This rental equipment is YOUR RESPONSIBILITY and any late and/or replacement fees will be the responsibility of you, the RENTOR.**

I understand the terms herein are contractual and not a mere recital and that I have signed this document of my own free act and with the knowledge that I hereby agree to waive my legal rights. I further agree if any provision of this Agreement is found to be unenforceable or invalid, that provision shall be severed from this Agreement. The remainder of this Agreement will then be construed as though the unenforceable provision had never been contained herein.
